**Meeting Overview:** Monday night's meeting was a mix of information sharing of long-range planning efforts such as the 82<sup>nd</sup> Improvement Project and Pedestrian Master Plan (PedPDX) and smaller projects occurring in the SE area. Radcliffe Dacanay, Project Manager for the 82<sup>nd</sup> Improvement Project shared data and information collected as part of a summary report on the current conditions and land use challenges along 82<sup>nd</sup> Avenue. The Bureau of Planning and Sustainability (BDS) is striving to get a head of future demand for development and redevelop along this corridor by thinking through anticipated issues like gentrification and design. BDS has started having conversations with business owners to support their desire to redevelop their property in a way that aligns with community-wide goals. Radcliffe encouraged LUTC participants to get out and walk or experience 82<sup>nd</sup> and adjacent properties and record what they experience to help inform this process.

Next, we heard from Michelle Marx from the Portland Bureau of Transportation (PBOT) who introduced the new Pedestrian Master Plan effort called PedPDX. After sharing some existing conditions data and project timeline, she encouraged participants to take part in the PedPDX survey and share it widely so that others may participate before it's cutoff date of September 30<sup>th</sup>. The meeting wrapped up with information shared on a local PBOT project, the Harrison-Lincoln Greenway. Local bicycle advocate and LUTC member, Terry Dublinski-Milton shared proposed improvements from PBOT along with suggested improvements to make this a world-class greenway. Proposed improvements are intended to slow and reduce vehicle traffic on this greenway. PBOT will host open houses in October to discuss the plans.
