BOARD DISCUSSION MEETING

7:00 The board discussion meeting was called to order.

Introductions + Announcements (Tina Kimmey, Chair)

- SE Uplift's mission statement and community agreements pertaining to behavior during board meetings were shared.
- Introductions and announcements were posted by board members in the chat.
- Recording Policy Announcements

Executive Director Report (Nanci Champlin)

- There will be no board meeting in August. Nanci will send a doodle poll out for an ice cream social in late August.
- SEUL just got DocuSign for signing all documents such as fiscal sponsorships.
- Lindsey has completed neighborhood emergency training. We've invested in an AED machine.
- Heating has been fixed in the building. We'll apply for Portland Clean Energy Grant in the fall.
- SEUL has invested in landscaping over the years. Backyard habitat gave us a gold certification for backyard habitat. There will be additional work this summer, and we'll provide tours.

Partnerships & fiscal sponsorships

NW Health Foundation has a small pool of funds for disability-led projects, and we were asked if we could be the fiscal sponsor. If the grantees are within SEUL district, we could provide fiscal sponsorship. NW Health Foundation sees civic engagement as a key to overall health.

We're also partnering with Bureau of Environmental Services via their Neighborhood to River grant program that will help us to hire and engage local brown and black artists to paint the electrical boxes around SE.

<u>Budget</u>

We just approved the budget for 22-23. We hadn't heard back yet on the level of funding from the city. The council will be voting in the middle of July. Commissioner Hardesty will be asking for 2 years' funding. We have the same level of funding for small grants as last year (over \$61k), and they also approved a cost-of-living adjustment (COLA) for DCOs. This results in a little over \$18K in additional funding, and Nanci would like to include in our budget. Nanci reviewed a slide which addresses what she'd like to spend it on (see attached.)

Nanci recommends we add:

• \$9,500 to personnel (3% for staff with corresponding increase in payroll taxes)

- Fiscal Services: \$4,000 (our bookkeeper)
- Professional development: \$2,000 (increase from \$600/staff person to \$1,000/staffer)
- Professional services \$2562 (intern or other capacity-building support).

The above will be in addition to the budget allocation we voted on at our last meeting.

If the NAs have nominated someone, board members will be asked to accept or reject their nomination.
