BOARD DISCUSSION MEETING

7:00 The board discussion meeting was called to order.

Introductions + Announcements (Tina Kimmey, Chair)

- SE Uplift's mission statement and community agreements pertaining to behavior during board meetings were shared.
- Introductions and announcements were posted by board members in the chat.
- Recording Policy Announcements were made

Seating of Neighborhood Association Board Members (Tina Kimmey, Chair)

Tina welcomed Kim Bandy as a returning board member representing North Tabor NA. There were no objections to seating her, so Kim is seated for the 2022-2023 year.

Executive Director Updates (Nanci Champlin)

- Nanci announced that Phoebe Gildea will be starting as Operations Specialist, replacing Lindsey Johnson in this role.
- SEUL's 2022 Community Small Grants and IDEA Communications grant applications open on Friday 10/7, with an 11/22 deadline. There's a total of \$72k budgeted. We are seeking volunteers to serve on the Grants Review Committee. The board will vote on the grantees at the board meeting on 12/5.
- There are 4 artists who will be painting utility art boxes, which is a public art partnership with BES.
- SEUL will host a charter reform forum on 10/13 via Zoom, with representatives from Portland United for Change, Partnership for Common Sense Government, and More Equitable Democracy.
- SEUL will hold a nature scaping event on Sat. 11/10 for participants to learn more about the backyard habitat program.
- We are planning a fall board and staff retreat, which will be a half-day on a Saturday or Sunday in late October or November. Board members are encouraged to complete the scheduling survey.
- Ex Comm is proposing a new board meeting schedule. We are required to meet 10 times/year, and we've been meeting 11 times. The first Monday where there is a holiday creates scheduling conflicts. The recommendations from Ex Comm include:

- o Keep the first Monday of each month for board meetings, from 7-9pm.
- o No meetings in January (due to New Year's holiday and historic light attendance), and July (due to vacations and Independence Day holiday).
- o If there are holiday conflicts, such as Labor Day, the board will meet on the first Tuesday of the month.
- Nanci shared a video with a primer on multi-winner rank choice voting, which is one of the elements of the charter reform measure.

Intro to the City's New Problem Solvers Program (Anne Hill, City of Portland Public Environmental Management Office ("PEMO") & Jacob Loeb, Montavilla NA)

Anne Hill made a presentation on the planned Problem Solver Meetings (see attached presentation). Board Networking Breakouts: What would you like to get out of the Fall Board/Staff Retreat? (Sharon Wynde, Board Administrator)

A breakout session was held with 5 groups to discuss what they would like to get out of the fall board & staff retreat. Comments will be collected and shared with Sharon to help plan the retreat content.

Board Learning Topic: Duty of Loyalty, Part I (Kat West)

Kat walked through a presentation on the Duty of Loyalty required as part of the fiduciary duties required of all nonprofit board members, according to Oregon State law (see attached presentation). Directors must put the needs and best interests of the nonprofit organization they service above all other considerations. It applies when deliberating, voting or otherwise making decisions and acting on behalf of the nonprofit organization.

Kat outlined the 4-step process to follow for Conflicts of Loyalty and walked through several examples of a conflict of loyalty.

 - o Just Crossing Alliance: this supports a new bridge on I-5 that addresses seismic resiliency, equity, climate justice and fiscal responsibility. SEUL's LUTC voted 6-2 to recommend membership with the Just Crossing Alliance at the Sept meeting. Membership is an agreement that SEUL endorses the Alliance. There are additional opportunities to be involved. A representative from LUTC has agreed to serve as the liaison. Matchu outlined what the Alliance supports, opposes, and who the other endorsers are.
