EXECUTIVE COMMITTEE MEETING

5:36 Call the meeting to order (Dave Weaver, Chair)

<u>5:37</u> Executive Director Updates (Nanci Champlin, ED)

Programs:

- Events:
 - Equi Institute Harm Reduction Fair, 12-4, Thursday, 5/20 at SEUL. There will be workshops, food, and activities.
 - Saturday, April 22nd from 3-4:30, Welcome Home Coalition; housing justice. In the SEUL Fireside room.

Operations:

- Sprinklers will be replaced by April 27th
- Lower-level restoration: now have a contract and scope of work confirmed with a contractor for removal of damaged flooring, drywall and baseboards
- Flooring upgrade out-of-pocket cost will be \$1,700, which is about a third of the original estimate. At the April board meeting, the board approved allocation from the building reserve fund to cover the upgrades. After allocating \$1,700, about \$9,100 of the allocation will remain.
- Allen Field filed more grievances against SEUL on April 10th. Deadline to respond is May 30th. SEUL will allocate staff to review grievances and develop findings and recommendations to submit to the board for review on May 1st board meeting or May 16th Executive Meeting.
- The SEUL Staff retreat last week was successful. We spent time on an elevator pitch on SEUL programming, completed a SWOT analysis, and rightsizing of goals. Staff are completing their workplans, which will culminate in June.

Finances:

- \$9,100 approved for building upgrades, which the executive committee will vote on to confirm agreement that remaining funding may be allocated toward a heat pump in the "Fireside Room"
- Kris & Nanci will be meeting this week to review Q3 financial statements and develop a base for next fiscal year's budget. By June, we'll be able to present this to the Board for approval, which means it'll go to through Finance and Ex Comm in May.
- We'll present the Q3 financial report at the May board meeting.
- Our houseless neighbor, John, will be departing the property by the end of the month as agreed. We will be providing him with \$200 to support his move, as previously agreed.
 Nanci has been in contact with immediate neighbors to coordinate other ways in which they can support John with his move.

 - \$260k 6-mo operation budget
 - Goal is to keep balances under the \$250k FDIC insurance limit
 - o Current operating bank is First Interstate Bank
