7:50 Review and Adopt FY 23/24 Operational Budget (Nanci & Doug)

- Doug presented the FY 23/24 operational budget (see attached) that includes two scenarios:
 - Scenario I represents a 2% reduction of the budget over last year
 - Scenario II represents a budget increase of approx. 9%. This is the version moving through City Council at this time. If the final budget adopted by the Council differs from either of these scenarios, the board will adopt an amended budget when it meets next in August (no July board meeting)
- City Council is expected to vote on FY 23/24 City budget on June 15. The grant contract is expected to be executed in July.
- Dave suggested that we consider diversifying our revenue sources moving forward so that we have additional sources beyond the contract with the City. Anna suggests bringing this suggestion to the committees to think about additional grant funding they may be aware of.

8:03 Board Learning Topic: The Portland Transition to Four City Council Districts – An Update and Discussion (Civic Engagement Committee)

- Every ten years the city will revisit the districts and use Census data on population counts. The Independent Districting Commission has evenly divided the population count for the four districts. As the city continues to grow, concern was expressed for considering anticipated areas of growth, but the IDC cannot consider future growth.
- Administrative organization was noted as more important objective
- The three options presented were similar but had distinct differences that all impact inner SE neighborhoods. The differences between the maps and which neighborhoods would be grouped with the west district were reviewed and discussed.
- Delivery of City services is mostly impacted by the fact that a city manager, not council, would manage bureaus. The new City Council would develop policy. Although a political dynamic comes into play with districting lines and maps.
- Dave encouraged Board Members to share and discuss this with your neighborhood associations / orgs for additional review and feedback
- Albert suggests looking at aligning the city and county in terms of districts.
- Christina expressed concern about Buckman potentially being part of the west side district. How might that impact zoning? They'll have the population from Buckman to increase the numbers, but the focus may not be on Buckman.
- Bruce looked at the maps, feels overall the IDC did a good job of dividing up by population. Didn't account for future growth; we need to see demographic studies. There will be more dense population happening in SE Portland, as well as the S Waterfront. If we don't account for that, we'll need to do this again in 10 years.
- Kim asked if there will be a report out? IDC has to reconvene for one or two more working sessions in August after completing a series of public hearings in July.
- Matt commented about operational service delivery benefits of charter reform.
- Kimberlea: Much of the service delivery will be impacted by the internal City reorganizing and reporting structure the new City Council will focus more on policy and legislating (service delivery is still a part of this, yes) which is where the political dynamic comes into play hard with districting lines and maps.
- A question was raised as to whether SEUL should facilitate a workshop to help communities with their messaging and outreach strategies for driving public input during the IDC public comment period that ends on July 22. Via a straw poll, 15 board members agreed that it would be helpful for SEUL to organize an opportunity to further discuss and communicate these maps with various neighborhoods and organizations as a means for facilitating awareness and opportunity to give input. Nanci will organize it.
