7:45 Executive Director Updates (Nanci Champlin, Executive Director)

- **Building Repairs:** Flood damage repaired; most covered by insurance and SE Uplift made some additional repairs/updates that aligned with the work being done
- **City Transition** re: new district maps for 3 city counselors to be elected in each of the 4 districts: public hearings were held in July; the districts commission must present a map decision by September 1; if commission is not able to decide, City Council will need to do it by December 1; district coalition areas and the neighborhoods that are in them will align with the new voting districts. If the final map divides a neighborhood, the neighborhoods may decide if they want to redraw their neighborhood boundary- the city will not impose this on neighborhoods.
- Programming/Services
  - We will be able to soon offer technical services agreement for bookkeeping support for former fiscally sponsored organizations. The contract, which has been reviewed by the Center f/Nonprofit Law, will be reviewed by Ex Comm.
  - Community Small Grants program will award over \$76k this fiscal year. Applications open September 1, due October 31. Community groups and/or nonprofits based in and/or serving our district are eligible to apply.
  - Training for Nonprofit Fundraising through Cogeo Wed 8/23 4-5pm (Planned Giving) and Wed 8/30 4-5pm (Data Management & Stewardship) – register if interested; can view recording later if you can't attend.
  - Events:
    - Scaling Up Your Food Sovereignty Program with Black Futures Farm Aug 12 for all interested.

- Discover Your Neighborhood Bike Rides Aug 20 highlight urban development and transportation, discover new spots within the neighborhood and BES murals.
- Portland Indigenous Marketplace at SEUL Aug 27- PIM is a current grantee; this marketplace will be concurrent with the street fair just blocks away. Come support indigenous makers and artists.
- Hawthorne Street Fair Aug 27 SEUL will table re: small grants program and share our table with City/County lead-prevention experts to provide info and test household items;
- Houselessness Action Committee Summit Sept 7, 6-8 pm; nonprofit resource fair, local micro village success stories and exploring the root causes of houselessness
- **Bylaws Amendment:** Discussed embedding the adopted Standing Rules for Grievances procedures into bylaws; rather than by reference. We'll be voting on this in the board business meeting.

8:00 FY 22/23 4<sup>th</sup> Quarter Financial Report + YTD Actuals (Sharon and Nanci in Doug's absence)

- YTD Summary (Sharon) annual budget \$620K
  - YTD Revenue exceeded budget by \$25k \$646K total
  - YTD Expenses exceeded budget by about \$24K
  - Net income of \$1,632 will go into unrestricted reserves.
  - \$29K from insurance settlement will be paid out to contractor in next fiscal year.
- 4<sup>th</sup> Quarter Balance Sheet (Sharon)
  - $\circ$   $\;$  Total Assets \$1.5M, which includes \$857k in cash and \$484k in Fixed Net Assets  $\;$
  - o Liabilities total \$497k primarily funds held for fiscally sponsored organizations
  - Equity of \$1M, which includes Building Reserve of \$100k, Operating Reserve (about 6-months' worth) of \$260k, and Unrestricted Net Assets representing prior years' earnings carried over of \$126K
