# <u>7:30</u> Presentation and Support Request Re: The Critical Energy Infrastructure Hub (Nikki Mandell and Laurie King)

- Critical Energy Infrastructure HUB purpose and location explained: bulk fuel storage on Oregon side of the Willamette near St. Johns neighborhood.
- A letter to Oregon legislators amplifying the need to address the risks associated with the CEI Hub during catastrophic events was read. CRI Hub Coalition reps request SEUL support in sending this letter.

### **8:10 Executive Director Updates** (Nanci Champlin, Executive Director)

- Building Update:
  - o Construction and final walk through scheduled to be completed this week
  - As need for rental space increases, SEUL will be able to offer space at a very affordable rate upon completion of construction. SEUL is looking to rent to mission-aligned orgs and civic leaders.
  - Looking to host an Open House in the fall
- New City Council Districts:
  - IDC approved an updated version of the Alder map.
  - Inner Southeast Portland will fall into District 3 including: Roseway, Rose City and Madison South.
  - Sellwood-Moreland, Eastmoreland, Reed, Johnson Creek Ardenwald, (and Ross Island which was considered part of Brooklyn) will fall into District 4.
  - Look out for an email from Nanci with a link to the updated interactive map of new District outlines.
  - Dave W and Nanci will be introduced to Roseway, Rose City and Madison South neighborhoods this fall.
- Community Small Grants applications:
  - Deadline to apply is October 31 and this year SEUL has over \$76k in grant funding to award.
  - Three categories this year: Micro Grant, Community Small Grant, Inclusion, Diversity, Equity and Accessibility (IDEA) Grant
  - Workshops for applicants will be offered on October 5th, 15th and 25<sup>th</sup>
  - Alex Cherin is heading the Grants Review Committee (GRC) and looking for 12 total volunteers to offer 10-15 hours of reviewing applications. Mandatory virtual meetings include an Orientation, and a Scoring Night Meeting. Stipends for participation are available including dinner on scoring night. The committee

will select a slate of awardees and present to the board for approval in December board meeting. Questions? Contact alex@seuplift.org.
