EXECUTIVE COMMITTEE MEETING

5:30 Call the meeting to order (*Kat West, Vice President*)

5:35 Executive Director Update (Nanci Champlin, Executive Director)

John (houseless neighbor) Update

- Has lived in and around property for 7 years wants to live off the grid, and has had several setbacks in making that happen
- SEUL allowed him to live on the property for over two years and had agreed upon a date in Summer 2023 when John would vacate the area. He vacated but moved to the church next door until they told him to leave.

- He has found his way back to residing in front of the SEUL property in the right of way in the parking strip and using multiple bike racks for his stuff. Since his return neighbors have expressed concern to SEUL and the City. The City sent an inspector who notified John that he is not allowed to camp on either property (with or without permission)
- Nanci has concerns for his safety as people are fighting him for his stuff.
- Phoebe is reaching out to Transition Projects on his behalf to find a place to store his stuff and temporary housing until he can move off the grid.
- Nanci asked if SEUL could co-sign with John for a storage unit that he would pay for. ExCom was concerned that this won't move the needle on the issue but want to understand what is the best use of our staff and members to help John make progress. At this point we are doing more to help John than John is doing.
- Nanci will let everyone know what the resolution is once Transition Projects gets involved.

Building Update

• Was hoping the building would be fully ready for the retreat, but some finishing touches still need to be taken care of (pipes and cables are still visible)

City Re-Organization update:

- As of this afternoon, a new organization chart has been distributed showing Civic Life under the City Administrator with NAs and DCOs part of Civic Life (as they are now)
- Council has adjusted final vote for the Organization chart to Nov 1
- City is looking for district locations to house the new Council members and SEUL is actively engaged in the conversations; members of the City property staff will visit SEUL facilities in November for a walk through.
