BOARD DISCUSSION MEETING

7:00 The board discussion meeting was called to order.

Call Meeting to Order - Dave Weaver, President

- SE Uplift's mission statement and community agreements pertaining to behavior during board meetings were shared.
- Announcements were posted by board members in the chat.
- Recording policy was announced.

7:10 Updates from Featured Board Organizations

- Baba Tunde, Black and Beyond the Binary Collective (BC3)
 - Organization celebrated 3 years on October 1 and began during the COVID pandemic out of a need for connection for this specific community
 - Four major programs: (1) Housing and Safety Funds for LBQT POC, (2) Umoja Kijana Shujaa leadership development program, (3) Forrest Program, (4) Creating social spaces [i.e. care package development, pride events, Portland night out event], (5) NEW Intern program
 - Have recently tripled staff and are looking for additional funding to support the new staff roles played
- Daniel Portis-Cathers, Mt. Scott-Arleta Neighborhood Association (MSANA)
 - Community center is under construction but has been used as the MSANA Meeting location for the past two years
 - MSANA Triangle project has been a successful re-purpose of a traffic corner to make it less dangerous and support community use
 - Traffic mandala behind 72nd Building
 - Hosted anti-racist training sessions have led to development of specific measurable achievable relevant and time-bound (SMART) goals that would be applied to MSANA meetings and future events.

7:25 Conversation with Portland City Commissioner Carmen Rubio

- The Commissioner oversees the city's Community and Economic Development service area which
 includes Portland Housing Bureau, Bureau of Development Services, Bureau of Planning and
 Sustainability, and Prosper Portland. Her priorities include the housing crisis, economic recovery, parks
 and natural resources, climate action, reimagining public safety, and building belonging in our
 communities.

- 2016 Housing Bonds are now fully allocated and have supported immense growth in affordable housing opportunities in the City of Portland

8:01 Conflict of Interest Refresher with Board Q+A – (David Atkins, Center for Nonprofit Law)

- Certain procedures are required if there is a conflict of interest present during non-profit board voting
- A conflict of interest is a condition where the board member would have financial benefit from the
 decision. To confirm that a condition is a true conflict of interest, 5 questions are asked to determine
 validity but starts with a declaration by the individual that has the conflict. These individuals must
 abstain from voting and leave the room during the vote.
- A conflict of loyalties is a condition that occurs when a board member has membership in numerous organizations. This is a matter of best practice expectations, not a required procedure. Process: (1) declare, (2) expose conflict, (3) abstain from voting
