Building: plumbing and drywall has finished up; heat pump installation is being scheduled; Phoebe and Nanci to submit for Clean Energy Grant which should finance roof, windows and heat/ac conversion to heat pumps

Programming:

- Civic Life announced new districts will go into effect on July 1 (including district coalition realignments).
- **Civic Life to host info session** in each district hosted by District Coalitions, SEUL will host a hybrid session on Feb 15, 6-8pm. Discussion will focus on liaison role of district coalitions
- Invited by Laurelhurst NA to partner for a district attorney candidate forum on March 12
- City Council Candidate Forums: looking to program Q&A's or info sessions with Land Use, Transportation, Climate, etc. themes/focus – perhaps this is planned in conjunction with NAs. Will know full list of candidates running by August 27
- District Coalitions: SEUL working with other DC officers to assess how to respond to upcoming changes brought on by City reorg. Schedule opportunities to welcome new neighborhoods falling under SEUL District
- Civic Engagement Leadership Academy: Alex and Machu working on a program to build skills in engaging with City organizations and staff on various subjects
- Rounds of meetings with key stakeholders (represented on board of directors) exploring SEUL's role as DC's and getting feedback on their needs going into 2024 arrange times with various stakeholders.
